

GIVE BACK WITH A DONATION OF SHARES IN 3 SIMPLE STEPS

Step 1

Fill out all sections of the attached securities transfer form.

For privacy reasons, your broker cannot disclose your name to us, so please complete the “donor information” section, including your phone number. Your adviser/broker will provide the CUSIP # (transaction number) that will be used as a reference if the transfer must be tracked.

Step 2

Send your completed securities transfer form to the Fondation Santé Urbaine.

Send us a copy of your completed form by mail or email. This step is important for the Foundation because securities are transferred to our bank account anonymously. Thus, in order for us to thank you for your donation and issue a tax receipt, you will need to provide us with your contact information.

Step 3

Send your completed securities transfer form to your investment adviser or broker.

Your investment adviser or broker is responsible for transferring your securities. Shares are considered to be officially transferred only after their reception has been confirmed by our agent. Your receipt will be calculated based on the closing share price on the day your shares are legally transferred to the Foundation’s account by our agent: RBC Dominion Securities. The Foundation’s policy on the sale of donated shares stipulates that all shares must be sold as soon as possible after they are received.
